測試流程：

樣本的處理步驟以無菌操作的環境下完成。取測試樣品在無菌燒杯中分別植入每一種試驗微生物，植入體積約佔樣品量之0.5~1.0%(v/v)，並使試驗微生物之最終濃度製備至 $1 \times 10^5 \sim 1 \times 10^6$ CFU/mL。將接種試驗微生物後的測試樣品，置於培養箱中震盪作用，分別於第14天及28天取出測試樣品，進行10倍序列稀釋後，於培養箱中進行培養，其培養條件如表一所示，之後進行計數。計算每一種試驗微生物在不同時間點之菌量減少之對數值(R)。








白色念珠菌(*Candida albicans*)
